PERIMETER PROBES 20,21,23 AND 9. CHECKED FOR METHANE. NO METHANE DETECTED. AT THE TIME OF INSPECTION, SCS WAS ONSITE DRILLING THE AREA NEAR PROBE 15 WHERE THE NEW GAS WELLS WILL BE INSTALLED. THIS IS PART OF THE REMEDIATION PROJECT TO BRING THE LEVELS OF METHANE BELOW 5%.

NO LITTER OBSERVED ON HWY 126 AND STREET SWEEPER WAS IN OPERATION.  
LIGHTING DURING DARK HOURS WAS SATISFACTORY AND NO TRASH /ODOR DETECTED IN THE VALVERDE AREA.  
AS A REMINDER, GREEN MATERIAL PILES MUST BE REMOVED AT LEAST EVERY 48 HRS TO PREVENT COMPOSTING AND FIRES.
