PERIMETER GAS PROBES 5,, 15 and 23. NO METHANE DETECTED AT THESE PROBES.

THE FOLLOWING RECORDS WERE CHECKED AND FOUND SATISFACTORY: SAFETY MEETINGS, DAILY AND SPECIAL OCCURRANCES AND COMPLAINTS.

BIRD AND DUST CONTROL SATISFACTORY.

LITTER WAS OBSERVED ON SLOPES AND ON AREAS OUTSIDE THE DISPOSAL AREA. LANDFILL STAFF IS TAKING ALL NECESSARY MEASURES TO CONTROL LITTER. LEA WILL MONITOR LITTER CONTROL IN THE FOLLOWING DAYS.

NO LITTER OBSERVED ON HWY 126 AND STREET SWEEPER WAS IN OPERATION.

LIGHTING DURING DARK WAS SATISFACTORY.
