Free Dump Days for Val Verde Residents

Chiquita Canyon Landfill will hold a series of Free Dump Days for Val Verde residents only. The landfill will allow free dumping from 6 a.m. to 2 p.m., and proof of Val Verde residency required (either a driver's license with a Val Verde address, or a utility bill with a photo ID). No hazardous materials will be accepted. This year's Free Dump Days will be held on the following days:

March 5 • June 4 • September 10 • December 3

Each pass allows the holder of the certification one (1) entry to the Chiquita Canyon landfill. Passes are on a "first come, first service base". No semi trucks allowed.
